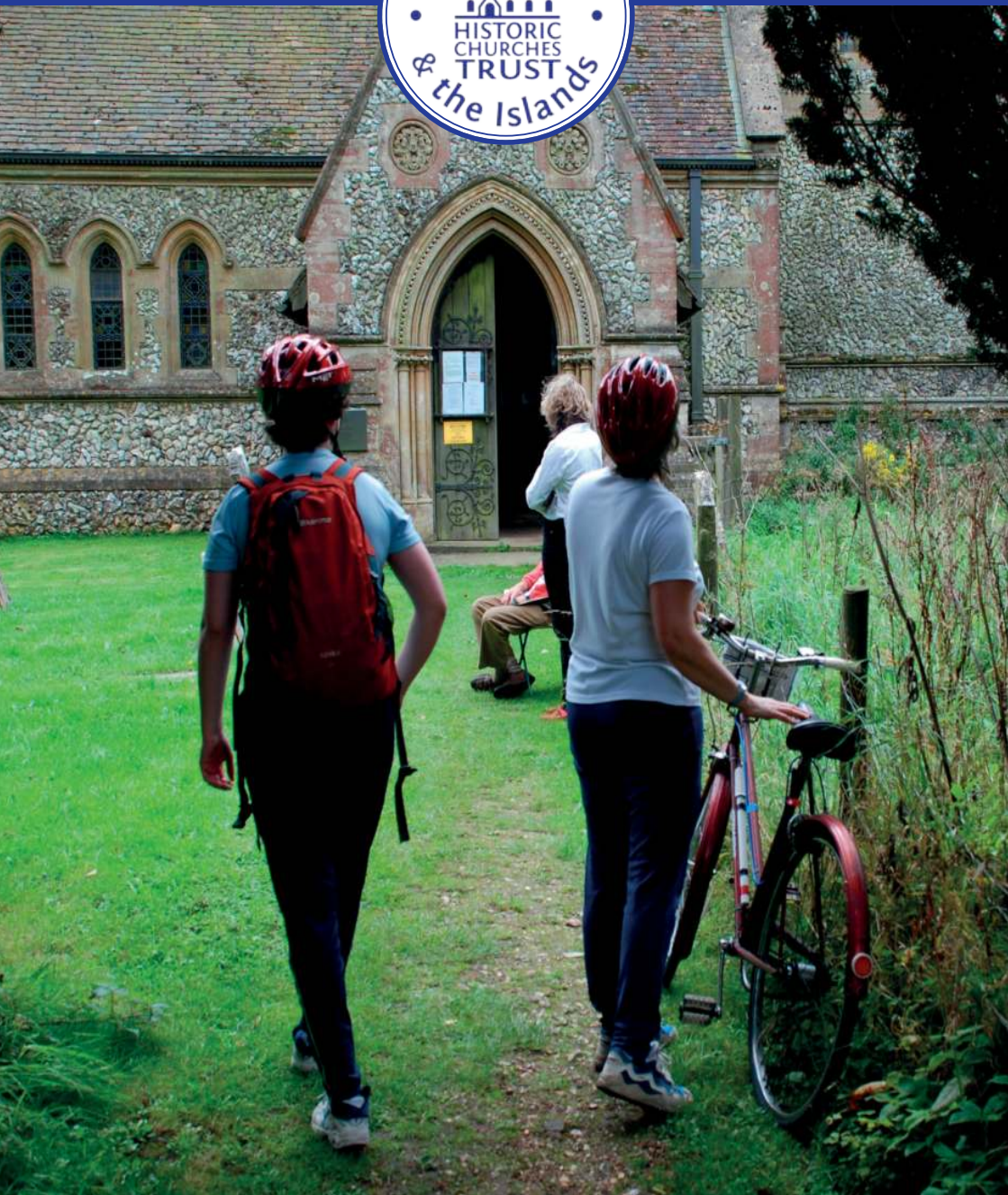

## FUNDRAISING

In order to provide the grants, funds are raised through the annual Ride and Stride, membership subscription, donations, Gift Aid, and grant aid.

The sponsored annual Ride and Stride in aid of historic churches takes place throughout the whole country on the second Saturday in September, organised by each county trust. In our area the money raised by participants is divided: half goes to the place of worship of their own choice, and half goes to the Trust. This is our principal source of funding.

Ride and Stride is an ecumenical venture, and although the majority of participating churches in Hampshire and the Islands are Anglican, it is well supported and enjoyed by a variety of other denominations including Baptist, Free Church, Methodist, Roman Catholic and United Reformed Church.

The Trust would like to thank all who contribute, through their hard work and generous support, to the success of Ride and Stride. Before and on the day this includes those involved in organising, riding, striding, sponsoring, stewarding, and providing refreshments. The day itself is also followed by much work in collecting, submitting and processing the funds raised.

## GRANTS

In 2019 we received 19 new grant applications from churches and we were able to make each of them an offer thanks to the tremendous efforts made by all of you who raise funds by participating in Ride and Stride each September. We are reliant on these funds to help maintain and improve Hampshire and the Islands churches. These wonderful places of worship serve their communities in so many additional ways and it would not be an exaggeration to say that they form the heart of their local community. It is impossible to overstate how grateful we are for your efforts. Please do keep up the good work so we can continue to help maintain our churches and preserve an important and historic part of the landscape for the benefit of all our communities.

### ***Grants received and given***

Applications in 2019 were 27% up on the year before. Thanks to a generous contribution from Hampshire County Council and the income from Ride and Stride, we were able to offer a total of £87,000 to churches, which is 15% more than the year before.

The Trust was awarded a generous grant of £25,000 from Hampshire County Council for the year 2019/20 and we are delighted to be able to allocate these funds to Hampshire churches on their behalf. It makes a huge difference to our ability to help those responsible for maintaining churches and improving accessibility. This

means the churches become accessible to a more diverse range of people and makes better use of these wonderful buildings in the heart of Hampshire communities. We are very grateful to Hampshire County Council for their support which is much appreciated by us and by historic churches across Hampshire.

### ***Corinne Bennett 8th Memorial Award***

Corinne Bennett was a founder Committee member with a particular interest in stonework restoration. In 2019, the award in her memory, worth £500, was presented at the AGM to St Mark's Church in Ampfield. The church is early Victorian, grade II listed and boasts an adjacent, fine woodland glade which is used by the church for many outdoor activities. Urgent repairs to the tower stonework were carried out and the original grant was claimed in early 2018.

Did you know that the Revd Wilbert Vere Awdry, creator of Thomas the Tank Engine, was born in the vicarage?!

### ***Grants Sub-Committee membership***

Meryl Balchin stood down from the Grants Sub-Committee at the end of 2019. We are very sorry to be losing her. Meryl has been a valued member of the Sub-Committee – and indeed, the main Committee – for over ten years and for much of this time she was Secretary. She handed over to Rosemary Walker in early 2016 but remained on the Sub-Committee. The recording and processing of grants underwent an organisational sea-change on Meryl's watch and she also developed an excellent relationship with the churches applying for grants. Thanks to Meryl, Rosemary inherited not only a system that was clear and efficient but also a great deal of good will from churches in our region. The whole Sub-Committee is grateful for Meryl's invaluable contribution and we shall miss her. Thank you, Meryl, for all you have done for us.

The Trust's Grants Sub-Committee comprises many professionals, all of whom provide their time and expertise pro bono.

### ***Trust membership and publicity***

All churches are encouraged to become members of the Trust and individuals are encouraged to join as Friends. Churches that are offered grants are asked to join for at least five years. We welcome invitations from churches who have received grants to join their celebrations on completion of works and to give a brief talk on the work of the Trust.

### ***Who may apply for a grant?***

The Trust welcomes applications from churches of all denominations which are members of Churches Together in England (CTE) and seeking funds for repairs to the church fabric or improvements to facilities, as detailed in the Policy Statement on page 16. ## RIDE & STRIDE 2019

Everyone agreed that it was a perfect sunny day for our annual Ride and Stride event to raise sponsorship money for the Trust. As usual, people did not restrict themselves to riding bicycles or walking but used any method of transport they wished from mobility scooter to car to horse. Or some provided local entertainment in a choir or by bell ringing.

Our Ride and Stride event is open not only to those who are members of a church community but also to all who appreciate churches for their beautiful architecture, their picturesque location and interesting expression of history and heritage.

But as important is the pleasure to be had from meeting the people who provide a welcome at the churches or who are visiting themselves. Father Hugo Deadman, approaching Portsmouth on his bicycle on his 17-church odyssey, noted the sign saying; ‘Welcome to Portsmouth! Home of the Royal Navy and Portsmouth FC, FA Cup Winners in 1939 and 2008’ and was tempted to add ‘Welcome to Portsmouth, home of fantastic churches and fantastic people’, because of the warmth of the welcome he had received. And again this year in Portsmouth, our indefatigable

supporter Brenda Cook enjoyed her trip round 14 churches using her mobility scooter, meeting friends and adding to the very handsome sum raised in the area.

Ride and Stride is open to all and many join in because they like the idea of travelling through our region’s countryside, its towns and villages, and understand that historic churches are an important part of our heritage and landscape. The encouragement of the clergy is, of course, very helpful in mobilising the support of the church community; they recognise that half the funds raised are returned to their church for their own needs, in addition to the availability of grants for projects which meet the Trust’s criteria.

In the newly constituted Mid-Test Benefice, David Barnes decided that he could do more than ride the short distance to his local Co-op and cycled 24 miles in the glories of the Test Valley – all are welcome! The ride extended from Leckford and Longstock in the north to Mottisfont in the south and included eight churches.



The churches are very varied although invariably beautifully situated and full of interest. The route between them is along quiet country lanes with lovely views. The Trust has made a grant to Leckford church to re-roof and repair the chancel roof. So, in addition to receiving half the Ride and Stride sum raised this year, the church has received a Trust grant. Hopefully, in future years the benefice will raise funds that can be used for other churches in need of help.

On the Isle of Wight, at Holy Trinity, Bembridge, children with their church mice companions, rather more cuddly than the real thing, went far and wide on the Island to discover what other churches had to offer and to raise money. They found the oldest church on the Island, St Boniface at Bonchurch (11th century) and their namesake church, Holy Trinity in Cowes. Amongst other visits they met a former choir boy of long ago who was at Holy Trinity, Bembridge but now at St Agnes, Freshwater. One particularly adventurous and remarkably mobile mouse managed to get to Capalbio, Tuscany, Italy.

North of Fordingbridge, Isabelle set out on her horse in idyllic surroundings and completed a ten-mile ride. She was accompanied by her father on a bicycle who went on to ride 22 miles and between the two they visited 13 churches. Isabelle and her friend Shannon rode to churches at Breamore, Rockbourne and Hale. The church of St Mary, Hale is grade I listed because it is so unusual and it is also beautiful. It is likely that the church was remodelled in about 1631 by Inigo Jones, the notable architect who introduced classical architecture to Britain. He was responsible for St Paul's, Covent Garden, London, and St Mary's has a striking resemblance. There are a number of architectural mysteries and inside, an outstanding collection of memorials. Altogether a wonderful church to include on a Ride and Stride route and perfect for horse riding in the sunshine.

In order to publicise the attractions of Ride and Stride to the wider community, our national coordination organisation arranged for 11 penny-farthing bicycles to ride into central Oxford down the Woodstock Road to the iconic St Giles' Church. They certainly stopped the traffic (but not for long), as cars stopped for the drivers and passengers to stare and as passers-by took photos. Subsequently, the event was featured in The Times, on Radio 2, and on BBC South television. We wait to see if a penny-farthing will feature in our event on 12 September 2020!

## ANNUAL GENERAL MEETING, 7 MAY 2019, WINCHESTER CATHEDRAL

An AGM is not an automatic crowd puller. We are fortunate to have a tradition of well attended meetings, partly owing to the setting in the Cathedral, the relatively streamlined business to be handled and the Venerable Adrian Harbidge's review of grants given in the year under review. This was delivered with customary urbanity and consummate knowledge of detail across the Trust's region. Finally, there was the excellent supper to foster fellowship.

Our President, Nigel Atkinson, Lord-Lieutenant, thanked the Chairman, Lady Appleyard for her work and leadership over the year and this was warmly endorsed by the meeting. The Treasurer reported that the change to CIO status (Charitable Incorporated Organisation) had been successfully completed without the need for a change of name, and that Ride and Stride income had reached a record £65,757.71 (exceeding the target). In addition, grants and donations had contributed over £52,700. Grants paid by the Trust had totalled £62,500 and the churches' share of Ride and Stride had amounted to £28,600. The Executive Committee was re-elected; its membership is listed at the end of this Report.

A key part of the meeting was the distribution of awards. The President presented the awards, to thank and congratulate many of our Friends for their outstanding efforts in Ride and Stride; in particular, Area Coordinators, Clive Bagwell and Cynthia Cooper (Andover and Petersfield, respectively); St Michael, Shalfleet, Isle of Wight, the top fundraiser; and Petersfield Area, the area raising the most money. The annual (8th) Corinne Bennett Memorial Award was given to St Mark, Ampfield. A new award, in memory of Brian Hay, one of our longest-serving supporters, was given to Holy Trinity, Weston, Southampton by his widow, Executive Committee member, the Revd Margaret Hay.

As Area Coordinator for Fareham and Gosport and Area Coordinator Rep on the Executive Committee, the Revd Margaret Hay spoke about what this pivotal role entailed, and the Venerable Adrian Harbidge rounded off the meeting with a whistle-stop tour of churches receiving help since the last meeting.

**VISIT TO STRATFIELD SAYE, 6 JUNE 2019**

The Trust's visit to Stratfield Saye was very well attended and lived up to everyone's expectations and more. On arrival through the main gates we were greeted by the magnificent drive up to the house, parking near the Visitors' Centre where refreshments were served. The head guide, Jenny Savage and her team met us and talked us through the arrangements for the day, to include the house tour, the Funeral Carriage and Wellington Exhibition, the Grave of Copenhagen (Wellington's horse), and the grounds. This was then to be followed by a separate visit to St Mary's Church, in the grounds.

Our tours in the house were splendid and very much enjoyed by everyone. Those of us who had not seen the Funeral Carriage before, particularly those with an engineering bent, were totally amazed at its size and how it managed to be built so quickly and look so spectacular, though we did feel a bit sorry for the driver as he was hidden underneath the carriage! A sign states: 'This Triumphal Car conveyed the body of Arthur, Duke of Wellington KG from Chelsea Hospital to St Paul's

Cathedral 18th November 1852. The lower part is constructed from metal of the guns captured at Waterloo in 1815. Weighing 18 tons, it was completed in 18 days, 100 men being employed working in two shifts. It was drawn by 12 black draught horses 3 abreast.'

After a delicious lunch, we all headed off to St Mary's Church which is on the estate but run by the PCC. Our enthusiastic guide, Geoffrey Preston, supported by some of the parishioners, gave us a great visit. Since 2010 the Trust has given this lovely Georgian church a grant and a loan to remove all the exterior paints (wrong sort used earlier and causing damp in the walls) and for roof works. A brief talk and then we were free to explore this wonderful church. Keith Miller, our Friends Secretary, played two organs! The cobwebby loft space was visited by a few intrepids to look at the bells (another project in the offing?). We really did explore every nook and cranny! This visit was a very fitting end to our wonderful day at Stratfield Saye.

Our thanks to all the guides and staff who contributed to such a successful day.

## SUMMER OUTING, 22 JUNE 2019, NEW FOREST RAMBLE

Our last church summed up the whole raison d'être of HIHCT - a perfect parable.

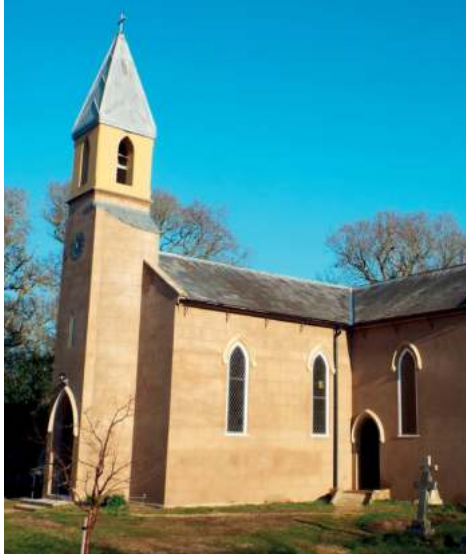
In *The Lion, The Witch and the Wardrobe* C S Lewis has a character describe the edge of the world as 'beyond the lamppost' (ie in the direction of the wardrobe and another world). I have the feeling that the 30 or more of us who came on the Summer Outing will think of Lyndhurst as the boundary between our world and another! For so many got trapped in traffic queues on the way to the **Old Oak at Downton** (and a delicious lunch), that our afternoon agenda was seriously delayed.

We began at **St Mary's Church, Milford**, a beautiful Grade 1 listed Norman church presiding over the seaside village since 1080. Christopher Hobby of the Milford Historical Records Society gave a superb talk focusing on the church's connection with the Navy: the grave of Admiral Sir William Cornwallis (famous for blockading Brest and preventing Napoleon from invading) has recently been rediscovered by the tower; inside the church are the graves of Admiral John Peyton and Admiral Robert Man (who at one stage commanded Nelson). Today the church has a very lively congregation and choir.

From there we went to **St John the Baptist, Boldre**, where Penelope Chitty entertained us with a history of the graveyard (looking idyllic on a hot summer's day) and the church. A lovely gravestone inscription speaks of the hope that the occupants will be raised to new life, there to see 'several of their neighbours' (but presumably not all!). The church is full of outstanding stonework but is probably best known for its memorial to all who died on HMS Hood, sunk by the Bismarck on 24 May 1941. Vice Admiral Lancelot Holland, who lived in Boldre, was killed on that day and his widow established the memorial despite official opposition.

In an isolated part of the New Forest it is often the case that the postcode may cover as much as half a mile of road, so we're not sure if we lost anyone who was sticking rigidly to their satnav. But for those who made it, **St Mary, South Baddesley** was a wonder to behold (and the provider of a delicious tea). Exactly 200 years old this year, it looks like a small mission chapel in the middle of nowhere. The cement rendering was giving a good impersonation of leprosy. Richard Elliott, the priest in charge told how the massive project to re-render in lime mortar and repair incredible cracks above most of the windows has transformed not just the building but also the congregation, who now flock to the church in increasing numbers, no longer ashamed of their church. Repairing our churches is not just about maintaining the crumbling fabric of old monuments.

## POLICY STATEMENT

Hampshire and the Islands Historic Churches Trust became a Charitable Incorporated Organisation on 28 December 2018. The Trust's foundation constitution states the aim of the Trust:

*The Objects of the CIO are the preservation repair maintenance improvement upkeep beautification and reconstruction of historic Churches in Hampshire (including the cities of Southampton and Portsmouth) the Isle of Wight and the Channel Islands and of monuments fittings fixtures stained glass furniture ornaments goods and chattels in such Churches and of the Churchyard belonging to any of such Churches for the benefit of the public.*

The Trust delivers public benefit by making grants and loans to churches for the purpose described above, thereby helping to preserve an important part of the country's heritage and supporting the ongoing use of churches as centres of worship and community amenities.

The Trustees have had due regard to the Charity Commission's public benefit guidance when exercising any powers or duties to which the guidance is relevant.

## TRUST GOVERNANCE AND OPERATION

The Charity operates as a Charitable Incorporated Organisation (CIO). It is a corporate body registered with the Charity Commission but does not need to be registered at Companies House or comply with the same rules as companies limited by guarantee.

The directors of the CIO who are known as Trustees are responsible for the management of the affairs of the CIO and may exercise all the powers of the CIO. There must be at least three Trustees but there is no maximum number. New Trustees are appointed by the existing Trustees. Trustees serve for a period of five years and can be reappointed.

The Trustees may delegate any functions to a Committee and have established an Executive Committee which meets three times a year. There are also a Grants Sub-Committee and a Marketing, Membership and Events Sub-Committee which report to the Executive Committee. Details of membership of the Executive Committee and Sub-Committees appear elsewhere in this Report.

Friends are an associate class of members of the CIO who may attend the Annual Meeting but under the constitution of the CIO are non-voting.

## RESERVES POLICY

The reserves policy of the CIO remains the same as that for the former Trust: the Trust aims to use the money it raises for the benefit of churches within its remit as soon as possible. A sum of £15,000 is earmarked in case of emergencies. Aside from a small annual expenditure on administration, the aim is to allocate the remaining

funds to churches in the form of grants and loans, in response to need. In any year a number of grants will be paid out while others will be offered, for payment on completion of the work being funded. The Annual Report provides details both of those churches receiving grants and of those churches being promised (but not yet receiving) grants during the year. The reserves policy is reviewed annually.

## BEQUESTS TO THE TRUST

As will be evident to all who read this Annual Report, Hampshire and the Islands Historic Churches Trust has moved from success to success since its inauguration in its original form in 1988. The needs of our churches are, however, very great and the Trust continually wishes it could be more generous in the support it gives for renovation and repair. Legacies from Friends and supporters can provide the Trust with an important increase in its income.

The subject of writing one's will is always a delicate one, but if you are contemplating making a will (or revising your present one) the following information could be of interest to you.

If your estate is taxable, the taxable portion will generally bear inheritance tax at 40%. Gifts to charities are not taxable so the whole of the amount that you leave to a charity will benefit the charity.

In addition, it is possible for a taxable estate to qualify for a lower rate of inheritance tax if the amount donated to charity is at least 10% of the value of the taxable estate but after adding back the amount of the charitable gift. The rules are complicated and professional advice should be taken if you want to benefit from this provision.

If you choose to leave the Trust a specific sum of money, a suitable form of wording in your will would be, 'I bequeath to the Hampshire and the Islands Historic Churches Trust, registered charity 1181370, c/o Pastoral Centre St Peter's Church Jewry Street Winchester SO23 8RY, the sum of £x.' Alternatively you can name the Trust as a beneficiary of a life insurance policy without making any change to the policy itself.

We always hope that there will be a considerable gap between the date of a will and the date of death, and of course we do not expect to be informed of anyone's intentions, but bequests for the Trust's work give us great hope that future generations will be able to enjoy, as we have enjoyed, Hampshire and its associated Islands' architectural and ecclesiastical heritage, without which their world would be a poorer place.

The above information is believed by the Trust to be correct at the time of going to print but you are recommended to take professional advice when preparing your will or undertaking any tax planning.

## **TREASURER'S REPORT 2019**

2019 was a busy year as it saw the charity transformed from a Trust to a Charitable Incorporated Organisation (CIO). Details of the transformation were set out in the Annual Report 2018. In summary, the CIO was formed at Christmas 2018 and started operation in April 2019. The assets and liabilities of the Trust were transferred to the CIO and in June 2019 the Trust was wound up. The name of the Charity remains unchanged but we now have a new charity number and new bank accounts.

A final set of accounts was prepared for the Trust for the period up to its dissolution. These accounts were independently examined by Rothmans in the usual way and approved by them. A new set of accounting records for the CIO was opened in April 2019 to take account of the transfer of assets from the Trust to the CIO. The accounting year for the CIO will coincide with the calendar year, with the first set of accounts being prepared for the period to 31 December 2019.

As the Trust has been wound up and removed from the Charity Commission register, copies of the final set of accounts for the Trust will not be provided to those who were formerly Friends of the Trust. However, if any Friend wishes to see a copy of the accounts they are available from the Treasurer.

Elsewhere in this Annual Report you will find details of the grants that have been promised but not yet paid. As the Charity pays grants once work is completed, there is often a significant delay between the promise to make a grant and the payment of it – churches are given up to two years to complete work. In view of this, the poor rate of interest paid by National Westminster Bank, and the need to keep our funds with them below the level of cover under the Financial Compensation Scheme, we have opened separate notice accounts and taken out a one year fixed rate bond with two other financial institutions. This has led to a significant increase in the level of interest earned on our funds.

The Charity welcomes legacies from Friends. If you have included a legacy in your will please ensure that the correct charity number, 1181370 is referred to.
